The Author will retain copyright in this article, and will assume any responsibility for registering the copyright with the U.S. Copyright Office. The Publisher will, however, register copyright on the entire serial issue of which the article is a part. As a condition of publication, the Author agrees with the Sponsor and Publisher on the terms set forth below.

The Author hereby grants to the Sponsor exclusive rights for first publication of this article in English. The Author also hereby guarantees that this article contains no matter which can be construed as libelous or as infringing in any way on the copyright of another party, and that he or she will defend, indemnify, and hold harmless the Sponsor and Publisher against all suits, proceedings, or claims that may be taken on the grounds that said article is in such violation.

The Author grants to the Sponsor and Publisher the following rights in regard to the article: the right to quote from the article in any promotional material on behalf of the journal; the right to photocopy the article for its own use; the right to republish the article in any future reprintings of the journal issue; the right to republish the article in any future reprintings gathered from the same journal; the right to grant permission to others for reproduction of the entire issue in which the article is contained, in all formats—including microfilm and electronic storage; the nonexclusive right to grant permission to others for photocopying of the article and for electronic reproduction and transmission of the article; the nonexclusive right to authorize republication of the article in anthologies, the nonexclusive right to publish and have published foreign language translations of the article for anthologies; and the nonexclusive right to use and distribute, and allow others to use and distribute, translated quotations and excerpts of the article in works published in foreign languages.
